In Yousefi et al (1393) revealed that early diagnosis and timely treatment of patients by specialists in emergency medicine can be waiting time hospitalization and reduce the levels of satisfaction promoted. The study Hosseini et al (2010) in connection with emergency problems were revealed the main reasons for the decrease BOR emergency, occupied bed days. Holliman et al (2012) study in relation to the emergency department revealed the majority of hospitals in terms of indices are in relatively good condition however, on some indicators, such as indicators of space, facilities and equipment and related activity such as referrals and beds. Contradiction was observed as compared to the standards of ministry that needs continuous attention.

Given the importance of the emergency department and problems, this study aimed to assess the emergency ward in Yasouj hospitals, compare it with existing standards of Ministry of Health and strengths and weaknesses, and strengthen them in their resolve finally providing appropriate services to help patients.

Research findings




Figure 1: Check the status of martyr Beheshti hospital emergency ward standards and Imam Sajjad (AS) in 2015 and compare it with standard Ministry of Health




Figure 2: Check the status of martyr Beheshti hospital emergency standards and Imam Sajjad (AS) in 2015 and compare it with standard Ministry of Health




Figure 3: Check the status of martyr Beheshti hospital emergency standards and Imam Sajjad (AS) in 2015 and compare it with standard Ministry of Health
